DIRECTIONS FOR USE - FOLIAR APPLICATION:

Corn: Apply 16 fl oz/acre between v4 and v8.

Soybeans: Apply 16 fl oz/acre between R1 and R3

Alfalfa: Apply 16 fl oz/acre after every cutting

Pome and stone fruit: Apply 42 fl oz/acre every 6 to 7 days beginning at complete petal fall for a total of 2 applications.

Table grapes: Apply 42 fl oz/acre every 8 to 10 days beginning at berry size 6-7mm for a total of 2 applications

Citrus: Apply 42 fl oz/acre every 12-15 days beginning after fruit set for a total of 3 applications

Cranberries: Apply 42 fl oz/acre every 6 to 7 days beginning at complete petal fall for a total of 2 applications

Melon/Watermelon: Apply 27 fl oz/acre every 6 to 7 days beginning after fruit set for a total of 3 applications

Processing tomato: Apply 27 fl oz/acre every 6 to 7 days beginning after fruit set for a total of 3 applications

Cucumber, zucchini: Apply 1.5-2.0 mL per liter of water every 5 to 7 days throughout the entire crop cycle

Eggplant, pepper, tomato: Apply 1.5-2.0 mL per liter of water every 5 to 7 days after fruit set of the first truss
